

If you want to know what someone was really like, go to his funeral and listen to his five children express their love and recount events they experienced with their father.

I knew George as a kind, gentle man, who adored his wife, Lila, and loved his fellow police officers. While I did not know George while he was on the Department, all accounts indicate that he was a good supervisor who was always looking out for his troops, but would not take any guff.

His dedication to the “troops” continued after retirement as he served as the Secretary/Treasurer of the AORP for many years. As the one he asked to take his place, I can attest to the procedures he set into place that were designed to help our members and their survivors; and the solid and respected relationships he established with members of the Police & Firefighters Retirement & Relief Board and the DC Retirement Board. These relationships and the respect George had garnered made smooth sailing for me when I explained, “I am the new George Suter.”

George served as the retired police officers’ elected representative to the DC Retirement Board (DCRB) for quite a few years. He was very dedicated to this responsibility and continued the work until he just could no longer do it.

At his funeral, his children talked about their father’s strength and gentleness; his humor and discipline; the love he had for his family and his dedication and loyalty to his police family.

As George was beginning to decline in health, one of his sons drove him to his monthly DCRB meetings. At the funeral, he recounted watching his father get out of the car, take his briefcase, square his shoulders and transform into the dedicated, determined man he had always known him to be.

# THE AORP CONTINUES TO PURSUE A SOLUTION TO THE TREASURY'S PURSUIT OF HUNDREDS OF OUR MEMBERS' PENSIONS

More than two hundred and fifty retired sworn members of the Metropolitan Police Department continue to be the subject of a "Correction Project" instituted by the U.S. Treasury's Office of D.C. Pensions (ODCP). The Correction Project began last year as the ODCP audited records of hundreds of our fellow officers, firefighters, and teachers who retired before July 1, 1997. As part of the bail out of the District Government, which was facing bankruptcy, the Congress assumed responsibility for all pensions earned through June 30, 1997.

The Treasury's ODCP did not bother to perform in depth audits of the pension records of the men and women for whom it has responsibility for more than fifteen years. This meant that retirees were fifteen years older. They had come to rely on their pensions. Most of the affected men and women are not in a position where they could begin working again to offset the reductions in the monthly pension or pay back thousands of dollars in past overpayments that Treasury said they owed. Retirees or their survivors were blind sided by this program.

The AORP directed their attorney to develop appeals templates for its members who were notified they had been over paid. The templates were distributed at meetings, emailed and faxed to members who requested them. More recently, the AORP provided a second template to dispute the findings by Treasury that the appeals would not be granted.

The Association has also been lobbying Congress and the City Council to seek legislation to require Treasury to abandon the Correction Project. Further, we are seeking funds from the District of Columbia to reimburse the officers and survivors who have seen their pensions reduced.

The discussions with the Congress and the Council are continuing. We wish to thank Senator Mikulski and Delegate Norton for their effort last Winter as they led other Members of the House of Representatives and the Senate to convince Treasury not to seek repayments from AORP members whose pensions were affected by the Max 80% and Look Back COLA issues, which constituted the greatest financial impact on our members. However, Treasury has decided to pursue all other overpayments that are not related to these two issues.

With the help of fellow AORP members, we have identified a conflict between what Treasury's ODCP is doing to our members and a policy announced by the Internal Revenue Service in March of this year. The IRS published a policy announcement which advised Plan Sponsors of Pension Funds, which discover past errors in the calculation of pensions by the employers or plan sponsors that resulted in over payments, that they were not required to recover the past over payments or to reduce annuitant's pensions. Yet, Treasury's ODCP continues to pursue recovery of past over payments and reductions in the pensions of members over whom it has authority.

In response to a June letter requesting a meeting, AORP President Gary Hankins, met with a professional staffer of the House Subcommittee on Government Operations and Reform. He related the history and present circumstances to the subcommittee representative and has remained in touch with him since. The AORP is requesting the development and passage of legislation that would prohibit the Treasury's ODCP from auditing the records of any annuitant who has been receiving a benefit for five years or more, unless there is evidence that fraud was committed to secure the benefit. (The June letter to the House Subcommittee is reprinted on page 4.)

If this legislation is passed, it would stop the Correction Project because all of our affected members have been receiving benefits for more than five years.

In July, our AORP President joined the President of the Retired Firefighters' Association, in a meeting with Congressman Hoyer's staff to ask that Mr. Hoyer support the legislation discussed above. They agreed to draft a letter to Treasury to ask that they suspend all of their debt collection efforts pending further review by the Congress.

AORP Vice President Bob Arcsott, who is an award winning member of the Maryland Republican Party organization, has agreed to use his influence to seek a meeting the responsible members of the House of Representatives to urge them to join in the push to pass the legislation the AORP seeks in order to protect our members.

The AORP is not resting on this issue. If we are unable to secure a legislative solution, we will move to court to seek relief for our members. But, the civil litigation route will be slow. It make take five years, with appeals, before it is completed.

Dear Chairman Meadows:

Approximately 250 retired police officers received letters from the U.S. Treasury's Office of D.C. Pensions (ODCP) beginning in January of 2015 as a result of its "Correction Project". The letters advised the recipients that an audit of their pension files have uncovered errors which result in changes to their pensions. The great majority of the letters relate to alleged overpayments made to the retirees. It provides the amount of the overpayment, whether the ODCP plans to collect any past overpayments, and how much they plan to reduce future pension payments beginning March 1, 2015.

There are three categories of errors. Two of them are errors based on alleged misapplication of the law. One relates to those who retired with 30 or more years of service. The other relates to the COLA Reach Back when COLAS were awarded on a semi-annual basis (two COLAS a year). This practice began in 1980 and continued through 1997. The third category are individual errors which they discovered while auditing the records that were reviewed.

With the help of many of our AORP brothers and sisters who contacted their Congressman and Senators, the ODCP agreed not to pursue past overpayments which resulted from the 30 years of service issue or the COLA Reach Back issue. They will continue to pursue individual overpayments which did not result from either of these two systemic errors.

Those who received one of these letters were entitled to appeal the decision to reduce their future pension payments as well as any collection of past overpayments. Many of our affected members did file appeals. Many of those who appealed were denied reconsideration. The letters they received advised them they could only appeal if they could identify errors in the re-calculation done by the ODCP or if they could show that the ODCP misapplied the applicable statutes.

The method of re-calculation, often relied upon dozens of pages records and interpretation of the proper application of relevant statutes' formulas and definitions of terms. The application of the proper statutes is even more perplexing. The ODCP's procedures for this project are inscrutable to the men and women who it has identified as receiving improper pension payments for as many as 17 years. The OCCP's legal decisions regarding what statutes are to be applied in the "Correction Project" and any appeals to its findings is even more confusing.

Some of the affected officers and their widows are advised they owe as much as tens of thousands of dollars in past overpayments. Additionally, their monthly pension payments may be reduced many hundreds of dollars. They are in the waning years of their lives. Many are disabled by injuries or age. Some are in assisted living. They are in no position sustain these reduction, which began in March of 2015, without serious consequences to their standard of living or standard of care.

I ask to meet with you to plead on their behalf for legislation that would prohibit the Treasury Department from collecting past overpayments or reducing future pension payments to annuitants under its authority unless the annuitant has committed fraud to secure payments to which he or she is not entitled.

The pool of annuitants under the authority of the ODCP shrinks with each passing year because the Congress assumed responsibility for those members of the District's Police Department, Fire Department and Teachers through June 30, 1997 as part of its agreement to resolve the City's financial crisis. Each month the number is reduced by deaths within the group.

The ODCP published an estimated value of approximately \$600,000 this year. As a result of the shrinking pool outlined above, this figure will also shrink to the vanishing point in approximate 20 years.

## **Maryland Property Tax Break May Be Available to Officers Disabled in the Performance of Duty And Survivors of Officers who were killed in the Line of Duty**

In 2007 the Maryland General Assembly passed a law which authorizes all of the counties in Maryland to adopt a law to exempt qualified sworn members of law enforcement agencies from paying property taxes. Thanks to the research of Brother Charles Lazarus we are able to bring this news to the members of the AORP.

Some Counties have adopted the Property Tax Exemption, but not all. If believe you may qualify for the exemption you should get in touch with your County government and make inquiries of the property tax offices. The general provisions appear below.

“Disabled law enforcement officer or rescue worker” means an individual who has been found to be permanently and totally disabled by an administrative body or court of competent jurisdiction authorized to make such determination and who is a law enforcement officer or correction officer whose disability arises out of and in the course of employment;

“Disabled law enforcement officer or rescue worker” or “fallen law enforcement officer or rescue worker” does not include an individual whose disability or death is the result of the individual’s own willful misconduct or abuse of alcohol or drugs, or the result of an occupational disease which did not result from an accidental injury within the meaning of those terms under the Maryland Workers’ Compensation Act.

“Dwelling” means real property that is the legal residence of a disabled law enforcement officer or rescue worker or a surviving spouse and occupied by not more than two families, and the term includes the lot or curtilage and structures necessary to use the real property as a residence.

“Fallen law enforcement officer or rescue worker” means: a law enforcement officer or correctional officer whose death arises out of and in the course of employment.

### **About the Qualifications regarding the Home**

the dwelling was owned by the disabled law enforcement officer or rescue worker at the time the law enforcement officer or rescue worker was adjudged to be permanently and totally disabled or by the fallen law enforcement officer or rescue worker, either individually or jointly with the surviving spouse, at the time of the fallen enforcement officer’s or rescue worker’s death;

the disabled law enforcement officer or rescue worker, the fallen law enforcement officer or rescue worker, or the surviving spouse was domiciled in the State as of the date the law enforcement officer or rescue worker was adjudged to be permanently and totally disabled or as of the date of the fallen law enforcement officer’s or rescue worker’s death, and the dwelling was acquired by the disabled law enforcement officer or rescue worker or the surviving spouse within two years of the date the law enforcement officer or rescue worker was adjudged to be permanently and totally disabled or the date of the fallen law enforcement officer’s or rescue worker’s death; or the dwelling was acquired after the disabled law enforcement officer or rescue worker or the surviving spouse qualified for a credit for a former dwelling under subsections (b)(1) or (b)(2) to the extent of the previous credit.

**Again, these are general provisions of the law. Be sure to contact the appropriate offices of the Maryland County in which you live to determine if you qualify for a Property Tax Exemption.**

# JUSTICE FINALLY SERVED FOR AORP BROTHER

*(Inspector Joseph M. O'Brien was appointed to the Metropolitan Police Department on November 17, 1952 and retired on May 31, 1979. During his tenure on the MPD, Joe spent many years in the Homicide Squad; from Detective to Captain. He died on January 25, 2005 as the result of a homicide. The Homicide Squad was a close knit family on the job and off, and there was special admiration for Joe O'Brien.)*

On December 17, 2004, an extremely intoxicated Wilfred Christopher Olalo was involved in three separate car accidents in less than a half-hour. The third accident was his rear-ending Joe O'Brien's car, without slowing down, and then backing up and hitting it again. The reporting officer indicated Olalo smelled strongly of alcohol and could not stand without falling.

In 2005, Nancy Anderson, who had been a civilian employee in the Squad from 1969-1981, notified retired Homicide Detective Bob Chaney that Joe had died from complications from the automobile accident. She, also, told Bob that the hospital had inappropriately ruled the death "Natural Causes". Nancy asked Bob to help her get retribution for Joe.

Joe's body had been removed from the hospital to a funeral home so Bob contacted Dr. Ann Dixon who was the Deputy Medical Examiner for Maryland in Baltimore. He explained the circumstances of Joe's death and the ruling. Dr. Dixon, who knew Joe, immediately had a member of her staff contact the funeral home and had the body transported to the M.E.'s Office in Baltimore.

Additionally, Dr. Dixon forwarded an order to Holy Cross Hospital, directing them to immediately forward all of Joe's medical records to her office. After reviewing the records, she promptly ruled Joe's death a homicide as a result of a drunk-driving accident.

Wilfred Olalo was arrested and charged with Joe's death. Pleading guilty in 2006, he was ordered to turn in his passport within 48 hours and to report for sentencing 60 days later. Instead he fled to Kenya.

Fortunately, at that time there were still individuals in the U.S. Marshal Service (USMS) who remembered Joe and his legacy. With those individuals assistance, Olalo's fugitive warrant stayed active and the USMS Fugitive Section never stopped their efforts to have him captured in Kenya and returned to the U.S. Nine years later, they were successful.

On June 24, 2015, Olalo was given the maximum penalty of three years for Joe's death. Additionally, he was indicted on a new charge for jumping bond which could carry an additional five years.

It was a long journey, but the maximum justice available was finally realized thanks to friends and former colleagues in the Montgomery County Police Department, the MD State Attorney's Office, and individuals in the U.S. Marshal Service. Had it not been for Nancy Anderson and Bob Chaney, this justice for one of our own would have never been achieved.
